Pursuant to the order of the Honble NCLT, Allahabad Bench, Uttar Pradesh Trading Company Limited (Uttar Pradesh) (one of the Promoters of the Company) has merged with Ganges Securities Limited. In view of the same, shares held by Uttar Pradesh have been transferred to Ganges Securities Limited and hence the Ganges Securities Limited has been shown under the category of Promoter. 4. Shareholders under Promoter/Promoter group are 17. Shruti family Trust, part of Promoter Group has sold its holding in the Company and hence is not reflected in this shareholding pattern, as the XBRL taxonomy is not accepting NIL/0 holding against Shruti family Trust.
