Textual Information()

1. Mr Chandra Shekhar Nopany is Significant Beneficial Owner as per the declaration received by the Company by virtue of his exercising significant influence in Palash Securities Limited.
2. Pursuant to the order of the Honble NCLT, Allahabad Bench, Uttar Pradesh Trading Company Limited (Uttar Pradesh) (one of the Promoters of the Company) has merged with Ganges Securities Limited. In view of the same, shares held by Uttar Pradesh have been transferred to Ganges Securities Limited and hence the Ganges Securities Limited has been shown under the category of Promoter.
3. Shareholders under Promoter/Promoter group are 17. Shruti Family Trust, part of Promoter Group has sold its holding in the Company and hence is not reflected in this shareholding pattern, as the XBRL taxonomy is not accepting NIL/0 holding against Shruti family Trust. In view of the same, even though, the total Promoter/Promoter Group has 17 entities/ individual, only 16 are reflected in this shareholding pattern due to the above reason.
4. In Table VI - Statement showing foreign ownership limits, we have considered shares held by Foreign Institutions and Non-Resident Indians for the purpose of calculating Limits utilized (%).
